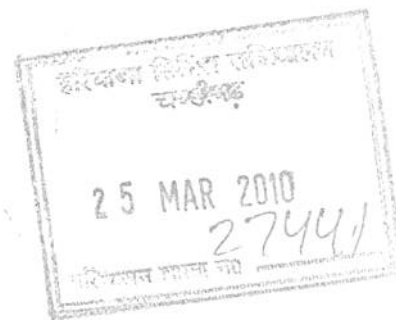

TRAINING CIRCULAR

Subject: A Group Training Course in 'Comprehensive Solid Waste Management and 3 R's (Reduce, Reuse and Recycle) Policies' to be held in Japan from 13<sup>th</sup> June, 2010 to 3<sup>rd</sup> July, 2010 under the Technical Cooperation Programme of the Government of Japan.

4. The nomination of suitable candidates may be done in accordance with the Department of Economic Affairs'O.M.No.1/13/03-PMU, dated 27.2.2006. The nomination details should be submitted on the following:

- (i) Prescribed Application Form
- (ii) DEA's prescribed proforma – duly countersigned by competent authority.
- (iii) The Country Report

5. Last Date of Submission: The completed 'application form' should reach this Department not later than 16.04.2010. Nomination received after the prescribed date will not be considered.
