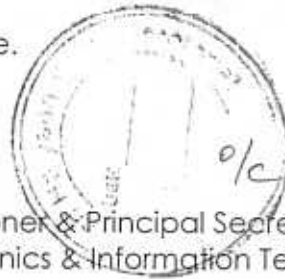

Mobile Subscribers of Haryana Telecom Circle while in roaming in above areas will be able to :-

- I. Make outgoing calls to Haryana subscribers at the same rate as if they are in home circle (Haryana).
- II. All incoming calls will be free during roaming.
- III. The key benefits, besides incoming free, to the subscriber roaming in above said areas of this facility is as under please:
