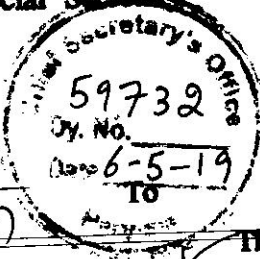

Subject: Posting of officers in the office of GST Council – regarding.

Goods & Services Tax Council (GSTC) Secretariat is a Constitutional body which has been constituted on 15<sup>th</sup> September, 2016. It is entrusted with the work of organising meetings of the GST Council including the drawing up of the agenda notes and preparing minutes of the Council meetings, assisting different Committees / Group of Ministers (GoM) constituted by the GST Council, examining various representations relating to GST Laws / Rules / Rates, administration and logistics etc. It also has the mandate to carry out tax research, printing, publication and documentation relating to GST.

2. In the Goods & Services Tax Council Secretariat, officers from both the Centre and the States are eligible to work.
